TERMS AND CONDITIONS

In the following contract, the Photographer shall mean Angus Forbes or a Photographer contracted by Angus Forbes. The Client(s) shall be those whose Name(s) appear on the booking form.

- 1) **Exclusive Photographer.** The Photographer shall be the exclusive photographer retained by the client for the purposes of photographing the Wedding. Family and Friends of the client will be permitted to photograph the Wedding so long as they don't interfere with the Photographer's duties.
- 2) **Deposit and Payment.** The fee for the photography of the Wedding is as stated on the booking form, a deposit of £200 is payable on booking and the remainder is payable on the day. In the event of the Wedding being cancelled or moved to an unsuitable date or venue then the full balance becomes due.
- 3) **Cancellation.** If this booking is cancelled by the client more than 6 calendar months before the date that was originally booked then no further charges apply. However if the client cancels the booking less than 6 calendar months before the original date then the full amount that was agreed and is specified on the booking form is due immediately. If the Wedding is then rebooked the amount paid will be deducted from the future booking assuming that the new date and venue are suitable to the Photographer
- 4) **Copyright.** The copyright of all images taken at the Wedding shall remain with the client. The Photographer reserves the right to use the images for any purpose including, but not limited to, self promotion.
- 5) **Failure to Perform.** If the Photographer cannot perform this agreement for any reason his liability will be limited to the refund of any monies paid to him. In this event every effort will be made to find an alternative photographer although no guarantee can be made that this will be possible.
- 6) **Coverage.** The Photographer shall be granted artistic licence in relation to the poses photographed and the locations used. The Photographers judgement regarding the location poses and number of photographs taken shall be deemed to be correct. Every effort will be taken to comply with the agreed list of photographs but the client should understand that on occasion some people may be left out due to time constraints or people leaving early. No liability will be taken by the Photographer if a person or people are left out. Occasionally Photographers movements, especially in Churches are limited, this may result in an obstructed view of the proceedings.
- 7) **Quality and Colour reproduction.** It should be noted that due to the limitations of Digital Camera sensors and photographic inks some colours may not reproduce exactly. Although equipment is checked regularly and all reasonable steps are taken to ensure backup equipment is available, the photographer will not be responsible for photographs that are not produced due to technical failure.
- 8) **Insurance.** The clients are advised to take out insurance in the event of cancellation on the day.
- 9) **Back up of images.** The Photographer will endeavour to hold a back up copy of images for 1 year but this service is provided free of charge and is not guaranteed. The Client is advised to make a copy of the Digital Media and keep it in a safe place.
- 10) **Liability.** The Photographer's liability is limited to the refund of any monies paid by the client, there are no exceptions to this.
